INDEMNITY BOND

The Indemnity Bond made at Agartala this 30th day of November, 2018 Between "The ICFAI Society" a Society registered under the Societies Registration Act, 1350 and now governed under the ICFAI University Tripura with its Headquarter located at Agartala-Simna Road, Kamalghat, West Tripura-799210 hereinafter referred to as the Association (which expression shall, unless it be repugnant to the context or meaning thereof be deemed to include its successors, assigns and persons for the time being having control over its assets and affairs); of the one part and the University Grants Commission a body corporate established and constituted under the University Grants Commission Act, 1956 hereinafter referred as the 'Commission' (which expression shall unless it be repugnant to the context or meaning thereof, include its successors and assigns of the other part.

Whereas the Association as the owner is conducting Various Educational Programmes at its Campus at Kamalghat, West Tripura, the University known as hereinafter referred to as the "ICFAI University Tripura".

And whereas the "ICFAI University Tripura" is constituted in 2004 under the provisions of an Act (Tripura Act No. 8 of 2004) passed in Tripura Legislative Assembly which was officially notified by Government of Tripura vide a Gazette Notification dated 04-09-2004 hereinafter referred to as the said University.

And whereas the Commission in carrying out its objects and functions has sanctioned grants out of its funds to the said University.

And whereas in order to regulate and control the use of the grant that may be made by the Commission to the said University as terms and conditions of the grant, the Commission has required the Association to execute this indemnity bond which the Association has agreed to do.

NOW THIS INDENTURE WITNESSED AND IT IS HEREBY AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERE TO AS FOLLOWS:

1. The Association hereby guarantees and covenants with the Commission that every amount of grant that will be given by the Commission to the said University shall when received by the said University solely be used for the benefit and purposes of the said University in accordance with the terms and conditions of the grants and not for any other purpose or any other institution run by the said Association and in the event of any part of the said grant being found to have been used by the Associations for any purpose other than the purpose of the said University or for any other institution run by the Association, the same shall be refunded by the Association without demur to the Commission on demand. The decision of the

Commission as to the misuse of the amount of grant and as to the quantum of the amount payable by the Association shall be final and binding on the Association.

- The Association further covenants with the Commission that the Association shall furnish to the Commission the balance sheet of the Association every year alongwith the annual audited Accounts of the said University managed or run by the said Association. The said Balance Sheet and the Annual Accounts will be sent to the Commission within two weeks from the passing thereof by the Association and in any event before the closing of the financial year of the Association.
- The Association hereby agrees to indemnify and keep indemnified the Commission against any loss that the Commission may suffer on account of the improper or misuse of the grant or any part thereof made by the said Commission to the said University or on account of non-use of the said grant for the said University.
