ICFAI Law School, The ICFAI University Tripura, having permanent Legal Aid Clinic at the campus. It was established by the Tripura Legal Services Authorities, Agartala on 23rd May 2015. The Clinic exists with the sole aim of bridging the gap between what law promises to offer and the actual realities of law. It follows the model of good governance through citizen participation, which believes that good governance will come about only when citizens at all levels of our democracy effectively participate. It always coordinates with the District and State Legal Services Authorities Tripura in solving the disputes of the local people. As part of Legal Aid Program, the students undertake some of



the programs under the supervision of the Legal Aid Clinic incharge and Legal Service Authorities of Tripura. Distinguished Speaker :


Mr. Prateek Dadheech, Civil Judge cum Metropolitan Magistrate, Jaipur Metro Sessions Court, Rajasthan

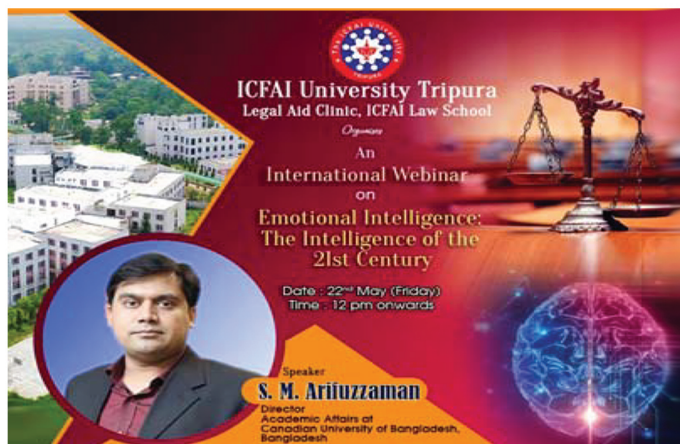

Sir also detailed about the Amendments and proposed modifications and the challenges faced in countering the pandemic situation with the available pieces of Indian Legislations. Sir compiled the session by lucidly curving out the aspired portrait of an ideal police official adequate to claim the title of Corona Warrior in truest sense in the present situation. The Constitution of India is a refined thesis of evolving jurisprudence regulating and defining the rights and duties of every stakeholders of the nation. Owing to it's dynamic dimension and adoptability, the Constitution of India is often known as a live document. Hence while teaching the very Constitution Law, a teacher has to be very fluid, thorough and adoptable so as to ensure that the students can actually realise the depth of the Constitutional Law, Constitution itself and the constitutional dogmas and tenets.

PROF. RAPHEAL HEFFRON,
Professor in Global Energy Law,
Sustainability and Just Transition, University of Dundee, UK



Prof. Heffron, made a very informative and innovative presentation on a very new and evolving yet indispensable legal dimension i.e. Energy Law & Sustainability in Transition. While human civilization ventures towards civilization with the invention of fire, the contemporary generation is progressing ahead with the developments of various forms of energy in various dimensions. Thus, the need of the hour is to harmonize and socialize the newly

evolving dimensions of energy to the benefits of the human society at large. Prof. Heffron, in his lecture had highlighted how laws are to be framed and adequately utilised both at domestic as well as international level to ensure the best utilisation of energy in consonance with the right to development of the future generation and the third world countries.

PROF. (DR.) AFZAL WANI

Professor, GGS Indraprastha University, Delhi



Prof. Wani is one of the eminent personalities in the legal academic for his scholarly works in the area of Legal Research methods and methodologies. His deliberation on the Dimensions of

Legal Research in Post COVID-19 World is a thorough lecture of the very conscience of legal research, its objective, prospects and future. Prof. Wani emphasised the ignorance and myth prevailing the arena of legal research which often consumes the young legal researcher's innovative thinking; and indulges them to make some monotonous compilations which are hardly contributing the existing socio-legal problems of our contemporary society. Sir has been enough to highlight the proper and most appropriate approach of an ideal legal research.

Professor of Law, Dean, Academic Affairs and Law, Head, Centre for Post Graduate Legal Studies, Chanakya National University, Patna



Prof. Kumar, in his informative deliberation on Changing Dimensions of Corporate Governance, highlighted the true role of corporate world towards the society at large. A corporation is

more merely a money-making agency but it is an institution that should stand with the integrity and prosperity of the society and nation at large. Prof. Kumar

explained that a corporation is fettered with several duties toward its employees, stakeholders, communities and society with adequate provisions of Corporate Governance in order to socialize and harmonize with the needs of the human society.

Prof. Bajpai, in his session discussed about the very fundamental models of the Criminal Justice Administration and Criminal Justice System, highlighting several key challenges that often

upsets the contemporary criminal justice mechanism by affecting the ideal workings of the foremost criminal justice agencies i.e. Police, Courts, Prosecution and the correctional system. Prof. Bajpai referred recommendations and suggestions of various expert committees and governmental bodies and advised the appropriate changes and modifications in the criminal justice administration that the Indian legislature is yet to consider.

PROF. (DR.) AZIMKHAN B. PATHAN

Professor of Law & Associate Dean, School of Law, Galgotias University Greater Noida



Prof. Pathan, added a new dimension to our contemporary approach towards legal research by his informative deliberation on the dynamics and significance of interdisciplinary approach

and research in legal education. Research is a comprehensive academic persuasion to curve out the complete solution of an unaddressed social problem. But unfortunately, researcher of a particular discipline often limits his research within the contours of his own discipline, and as a result the proposed solution of the research often remains incomplete because of the ignorance of the relative dimensions of the researched problem which can be realised only by having an interdisciplinary knowledge about the researched problem.

Dr. Sayapin, an eminent international personality of the field of International Criminal Law, has made out a very lucid and yet exhaustive deliberation

on the field of teaching International Criminal law and dealing with the crises of jurisdiction in implementing criminal law at the international level. However, Dr. Sayapin also explained the developments made in this arena both domestic as well as internationally. Sir, made a composite analysis of various crucial international common standards from both the International Human Rights and the International Humanitarian Laws, from the context of the International Criminal Law. He also acknowledged the role played by India in the International Criminal Law.

Prof. Ahmed, in his deliberation on the Bloom's Taxonomy and Outcome Based Teaching Learning Process in Legal Education, discussed about several approved and appropriate parameters of legal teaching in legal education. Dr. Ahmed discussed the rationales for emphasising the need of a law teacher to have adequate knowledge about the objectives and outcome of a program; and the law teacher should accordingly reframe his class and course handouts or course design; and at the same time the teacher should also consider the students learning ability and adoptability to a particular course deliberation design.

Prof. Mishra, in her deliberation on the Human Rights of Vulnerable Groups with Special Reference to Victims of Domestic Violence, made a very detailed and exhaustive illustration and analysis of the past wrongs and presents reluctance and ignorance towards the rights of women section from the legal

context, both at domestic as well as international level. 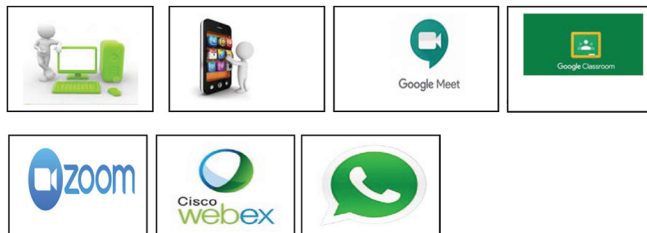
WORK FROM HOME

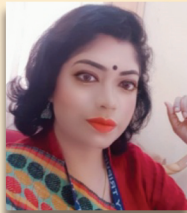
