IDIA started out as a student run movement in 2010. Today, IDIA Charitable Trust is a registered trust, comprising the following trustees: Justice Ruma Pal (a former Supreme Court judge); Prof. (Dr.) M.P. Singh (a leading legal scholar); and Mr. Shishira Rudrappa (Director, Spire Capital).

It was started by late Prof. (Dr.) Shamnad Basheer, the founder and the brain behind IDIA. Our operations team comprises an Executive Vice President and a team of Directors; and a strong network of more than 600 student volunteers across 23 different states of India. We are also guided by a strong body of advisors and partners, comprising leading names from the legal profession, academia, industry, civil society and government.

What IDIA do

Sensitisations: IDIA runs on the backbone of its 600+ student volunteers, drawn from leading law universities across India. These student volunteers travel across the length and breadth of India (from the Sunderbans in West Bengal to Baramulla in Jammu & Kashmir) to identify and sensitise underprivileged students to the power of the law, and the diverse range of career options that await them.

Training: Interested students are screened through a basic aptitude test (carefully designed to test logical reasoning and critical thinking abilities). They are then put through a rigorous training schedule for up to 2 years, including classroom coaching from India's leading law entrance (Common Law Admission Test or CLAT) coaching centres and trainers.

Scholarships: Once an IDIA trainee is admitted into a law school, IDIA arranges for scholarships to support their education.

Creating Champs: IDIA's job does not end with merely facilitating law school admissions for underprivileged children. Rather, the ultimate goal is to produce leading lawyers and community

advocates who are "creative, holistic, altruistic and maverick problem solvers" (CHAMPS). To this end, IDIA has conceptualised a rigorous training and mentorship programme to help each IDIA Scholar to blossom to their fullest potential.
