Memorandum of Understanding

This agreement is made and executed on this 29th day of March 2017

BETWEEN

ICFAI University, Agartala-Simna Road, P.O Kamalghat, Agartala, a University established in 2004 through an Act of State Legislature (Tripura Act 8 of 2004) herein after called IUT,

District Disability Rehabilitation Centre, Shyamali Bazar Agartala herein after called DDRC.

PREAMBLE
The IUT was established in 2004 through an Act of State Legislature (Tripura Act 8 of 2004). The University has been approved by the University Grants Commission, under Section 2(f) of the UGC Act, 1956. The ICFAI University, Tripura is included in the list of universities maintained by the University Grants Commission (UGC) under Section 2(f) of the UGC Act, 1956, vide their letter No. F.9-7/2006 (CPP-I) dated October 30, 2006.

The Visitor of the University is H.E. the Governor of Tripura. The University is administered as per the Act, Statutes and Rules. The Board of Governors is headed by the Chancellor and has Vice-Chancellor, Pro Vice-Chancellor and others as members. The board also comprises of representatives/nominees from the Govt. of Tripura.

The University offers Bachelor, Master, and Doctoral programs in Management, Rural Management including Agri Business Management, science and technology, Education, law and other areas.

District Disability Rehabilitation Centre, DDRC Shyamali bazar ,Kunjaban, Agartala, Tripura (W) Tripura-799 006, under the G.P.Y Scheme of Ministry Social Justice & Empowerment Govt. of India was inaugurated by Hon'ble Chief Minister of Tripura Sri Manik Sarkar on 11th December 2001. DDRC-West is working under "District Rehabilitation Society for Disabled" & supervised by District Management Team (DMT). D.M & Collector, West Tripura is the Chairman of the both the Management Team and Society. A.D.M & Collector is the Vice Chairman of Management Team and Society.

There are various units of DDRC i.e OPD Complex Prosthetics & orthotics Workshop Ear Mould Workshop, Audiometric, Eye checkup. IQ determination. Physiotherapy unit. Special Education ,Training Centre- Doctors ,VRW / MRW .School Teachers, Rehabilitation Workers including NGO.

Various Activities of DDRC are Registration and counseling, Patient examination and treatment (Eye, ENT, Ortho & Mental), Corrective surgery, Physiotherapy, Manufacturing of artificial limbs, caliper, dresses modified shoes, splint etc. Manufacturing ear mould, Distribution of aids and appliances, Issue of Disability Certificate on every Wednesday from OPD, Survey at OPD, Issue of Certificate.

Outdoor Service: - Awareness Camp, Identification Camp, Certification Camp, Distribution Camp, Survey at Block level Camp Publication & documentation, Sponsoring Candidates for vocational training & higher Education, Survey at Gram Panchayat Level, Niramoy Health Insurance Scheme, and Guardianship under National Trust.

COLLABORATION AGREEMENT

The discussions and interactions between IUT, Faculty of Education and FRC indicated that they share common mission, objectives and ideology – that is Counseling for rehabilitation educational programme to physically, mentally and hearing impairment children.
