BETWEEN

Directorate of Health Services, Covernment. of Tripura, to be represented by Dr. Subhasis Debbarma, S/O Mr. Asoke Debbarma having expertise in the area of providing healthcare benefits and facilities of Government of Tripura, having its office at New Capital Complex, P.N, Gurkhabasti, Kunjaban, Agartala, Tripura 799006, herein referred to DHS as the FIRST PARTY;

AND

The ICFAI University Tripura is Self-Financed Private University to be represented by Dr. A. Ranganath, S/O Late A. Govindo situated at Kamalghat, West Tripura (India)-799210, herein referred to IUT as the SECOND PARTY;

Whereas the first aforesaid institution is hereinafter referred to as DHS and second aforesaid institution is hereinafter referred to as IUT and both collectively as institutes. Also that the students of Allied Health Sciences, Laboratory Technology and Hospital Administration programs from IUT hereinafter will be referred to as only students. Both the institutes have agreed mutually that DHS to provide facility/platform for undergoing IUT student's internship program and on the other hand IUT to send students to avail the service as stated above following Government of Tripura guidelines.

Whereas using the DHS service, which will include providing facilities to undergo internship program, IUT is entering into a binding contract with DHS in our country of residence. The agreement includes following terms and Conditions.

TREMS & CONDITIONS

PURPOSE & SCOPE:

- DHS to allow IUT Allied Health Sciences, Laboratory Technology and Hospital Administration students for pursuing internship and their Clinical posting at Government of Tripura Hospitals (GBP & IGM) situated in Agartala.
- Jointly Conducting Lecture Session, Seminar, Workshop and other collaborative works.
- Organizing collaborative extension activities like Health & Blood donation Camps.
- Planning and organizing seminar, conference, workshop, training and capacity building programmes

GENERAL PRINCIPLES:

- Intern shall follow the timings while reporting and leaving the institute.
- Every intern, who joins the institute, must follow the protocols of the institute. The protocols will be guided by the institute member after the joining.
- Provide appropriate managerial services.
- Maintain the quality and standards of health education practices.
- Intern shall also maintain a daily logbook on the progress of the internship and should be countersigned by internship mentor every day.
- Intern shall take care of their belongings and laptops while on internship inside the premises of FIRST PART

3. DHS RESPONSIBILITIES:

- To allow IUT students for pursuing Internship and Clinical posting at Government of Tripura Hospitals (GBP & IGM) situated in Agartala.
- Enforce their respective policies and procedures governing the behaviour of Hospital staff in order to provide a professional work and learning environment for interns.
- Providing the assessment report, training completion certificate and attendance report of the students to the ICFAI University, Tripura during the Internship
 - DHS/Hospital does not have any financial liabilities towards the students of IUT.

4. <u>IUT RESPONSIBILITIES:</u>

- IUT has to bear necessary fees for conducting Internship and Clinical exposures according to the Government of Tripura Rules.
- IUT has to send necessary list of students along with their particulars to DHS before conducting Internship and Clinical exposures at Government of Tripura Hospitals in every semester.
- IUT to arrange necessary recovery charges from students against damage of any clinical items caused during the Internship
- Providing a mentor to the interns for guidance and knowledge.
- IUT to organize Workshop, Conference, seminars, health camps and Blood Donation camps in association of DHS.
- IUT to conduct Joint Research & Project in collaboration with DHS.

5. VALIDITY & TERMINATION:

- This memorandum shall come in to force immediately upon its signature by the both parties.
- This MOU will be in effect until either part indicates that the institutional relations will be terminated or modified upon prior notice in writing not later than six months before the termination date.
