Lokpriya Girls College, Kalgachia, a General Degree College under the Department of Education (Higher), Government of Assam, is situated at Kalgachia with natural scenic like green park of the district of Barpeta, Assam, Pin- 781319 herein after called 'LGC' represented by Dr. Arshad Ahmed, Principal In-charge, which expression shall unless repugnant to the context or meaning thereof, be deemed to include its successors, legal representative and permitted assigns,

AND

The ICFAI University Tripura, a University established under Section 4(2) of The Institute of Chartered Financial Analysts of India University Tripura Act of 2004, enacted by the State of Tripura, having its Campus at Village Kamalghat under Mohanpur Sub Division in West Tripura district-799210 (hereinafter called as "IUT"), represented by **Registrar Dr. A Ranganath**, which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns.

Lokpriya Girls College and IUT are independently referred to as 'party, and collectively as "parties". The parties agree to engage into broad spectrum of joint activities in the fields of promotion of educational programmes, Research Activity, Faculty & Student Exchange, Training programmes, SME Business Development and Sustainable Livelihood Promotion in the North -Eastern part of India. This MoU shall be treated as the guidelines on which both parties agree to work together in future. The terms and conditions of this MoU are mentioned in following para-

1. BACKGROUND

Lokpriya Girls College is an institution which wants to enrich the women education and empowerment of mentality of the female section with adjustment of modernity. It is mentionable that this Girls College is situated amidst of ninety five percentage of minority Muslims Community and Muslims women are also educationally backward and illiterate. So to take better position of said section also the aims of the Girls College and Provide students all possible opportunities to acquaint them with modern techniques and encourages them to conduct research activities

2. PURPOSE & SCOPE

The goal of cooperation will be accomplished in various ways which may include:

- Exchange of researchers
- Conducting Faculty Exchange Program by IUT for LGC
- Exchange of scholarly and pedagogical materials
- Joint research
- Technical assistance and/or training
- Facilitating admission of students to ICFAI University Tripura from LGC
- Extending collaboration for implementation of Sustainable Development Goals and Education Sustainable Development (ESD) Practices.
- Other cooperative efforts as may be specified later.
- Conducting career development seminar by IUT for the students of LGC

3. OUTLINE OF COLLABORATION

Under the aegis of this agreement, the parties shall jointly explore the possibilities of working mainly in the North Eastern part of India. The broad areas of cooperation would include the following:-

- a. Mutual exchange of Faculty and students for Regular & ODL programmes;
- b. Taking up studies and action research projects on socioeconomic analysis, livelihood security, market intelligence, value chain and other areas of research in NE region of the country ;
- c. Mutual help in promoting placement of the students of both the institutions in the private sector.
- d. Planning and organizing seminar, conference, workshop, training and capacity building programmes in the domains of entrepreneurship, livelihood promotion, new enterprise creation and cluster development and other common area of specialization of both the institutions.
- e. Based on speciality in the field, cooperation among the faculties of both institutions for carrying out research in various programmes.
- f. Undertake joint activities in rural areas under national flagship programmes like Mera Gaon Mera Gaurav, Swachh Bharat Abhiyan, Unnat Bharat Abhiyan etc and other central & State Government projects.

The separate Terms of reference (ToR), deliverables and sharing of the credits including intellectual property rights will be laid down with mutual consensus at the beginning of the activities.

4. PERFORMANCE STANDARD

The parties shall perform their respective roles and responsibilities under this MoU with highest standards of professional and ethical competence and integrity. Both Parties shall also respect rules, regulations and policies of both institutions.
