Swami Vivekananda Mahavidyalaya, Mohanpur (herein after called as SVM Mohanpur) a government degree college, established on 4th August 2012 affiliated under Tripura University (A Central University), represented by **Dr. Haradhan Saha, Principal**, which expression shall unless repugnant to the context or meaning thereof, be deemed to mean and include its successor, legal representatives and permitted assigns.

AND

The ICFAI University, Tripura, (herein after called as IUT) a University established under Section 4(2) of The Institute of Chartered Financial Analysts of India University Tripura Act of 2004, enacted by the State of Tripura, having its Campus at Village Kamalghat under Mohanpur Sub Division in West Tripura district-799210, represented by **Registrar Dr. A Ranganath**, which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns.

SVM Mohanpur and IUT are independently referred to as 'party, and collectively as "parties". The parties agree to engage into broad spectrum of joint activities in the fields of promotion of educational programmes, Research Activity, Faculty & Student Exchange, Training programmes, SME Business Development and Sustainable Livelihood Promotion in the North -Eastern part of India. This MoU shall be treated as the guidelines on which both parties agree to work together in future. The terms and conditions of this MoU are mentioned in following para-

1. BACKGROUND

The College derives its strength from the teachings of Swami Vivekananda. "Learn everything that is good from others, but bring it in, and in your own way adsorb it, do not become others". The vision of the Mahavidyalaya is to become a model institution having deep rooted traditional

The college strives to empower all its students by inculcating discipline, imparting punctuality, enhancing learning potential, emphasizing on acquiring physical & mental strength, developing character and leadership so that they possess a broader outlook towards the society, have humanity and can do selfless and relentless service towards the society for their whole life.

2. PURPOSE & SCOPE

The potential areas of collaboration include academic & research, capacity building programme, experience sharing and knowledge management in the domain of entrepreneurship development and sustainable livelihood promotion etc.

OUTLINE OF COLLABORATION

Under the aegis of this agreement, the parties shall jointly explore the possibilities of working mainly in the North Eastern part of India. The broad areas of cooperation would include the following:-

- a. Designing viable and feasible roadmap for joint activities.
- b. Taking up studies and action research projects on socioeconomic analysis, livelihood security, value chain and other areas of research in NE region of the country.
- c. Mutual help in promoting placement of the students of both the institutions and augmenting Employment opportunities.
- d. Planning and organizing seminar, conference, workshop, training and capacity building programmes in the domains of entrepreneurship, livelihood generation, new enterprise creation and cluster development and other common areas of specialization of both the institutions.
- e. Based on speciality in the field, cooperation among the faculties of both institutions for carrying out research in various disciplines.
- f. Undertake joint activities in rural areas under national flagship programmes like Ek Bharat Shrestha Bharat, Swachh Bharat Abhiyan, Implementation of NEP 2020 related programmes, Unnat Bharat Abhiyan, etc and other central or State Government projects.
- g. Extending collaboration for implementation of Sustainable Development Goals and Education Sustainable Development (ESD) Practices.
- h. Conducting career development seminar by IUT for the students of College of SVM Mohanpur and vice versa.

The separate Terms of reference (ToR), deliverables and sharing of the credits including intellectual property rights will be laid down with mutual consensus at the beginning of the activities.
